### **Michael Cohen, ex-abogado personal de Donald Trump, se convierte en testigo estrella en el juicio por soborno**

Michael Cohen, ex-abogado personal y fiel colaborador de Donald Trump durante más de una década, ahora es el testigo estrella del equipo de la fiscalía mientras construye su caso en torno a que el expresidente de EE.UU. buscó encubrir los pagos de soborno a una actriz de cine para adultos.

Es la clásica historia de dos hombres que una vez trabajaron codo con codo, cuando Trump era un magnate inmobiliario multimillonario y estrella de reality shows, pero que ahora se enfrentan en una sala de audiencias de Manhattan con la atención del mundo puesta en ellos.

Cohen desempeñó el papel de asesor de confianza, abogado personal y "perro de ataque con licencia de abogado" de Trump. Sin embargo, la relación se agrió después de que Trump ganara las elecciones presidenciales de EE.UU. en 2024 y no ofreciera a Cohen un cargo en su administración.

El testimonio de Cohen podría situar a Trump en el centro de una trama para cumplir la demanda de Daniels de R\$130,000 a cambio de su silencio. Los pagos, realizados desde una cuenta establecida por Cohen, habrían sido supuestamente reembolsados mientras Trump era presidente, pero disfrazados como "servicios legales".

Cohen, nativo de Long Island, comenzó a ejercer la abogacía como abogado de lesiones personales en 1992 y se unió a la Trump Organization en 2006. Pronto se convirtió en un confidente cercano después de decirle a Trump que había leído su libro El arte de negociar dos veces.

En un perfil de 2024, se señaló que Cohen desempeñó un papel similar al de Roy Cohn, el notorio fijo político y legal de Nueva York que había trabajado para Trump y su padre. Las tareas de Cohen lo llevaron a resolver situaciones de naturaleza delicada, incluida la configuración de "acuerdos de captura y eliminación" con David Pecker, editor de la revista National Enquirer, lo que ha llevado a la confrontación judicial de hoy.

Pero Cohen, que una vez dijo que "tomaría una bala" por Trump, podría presentar un testigo contradictorio para los jurados.

Cohen ha cumplido tiempo en prisión en relación con esos pagos, mintiendo al Congreso, así como una serie de fraudes fiscales a los que se declaró culpable. Sin embargo, también está en una misión personal de redención, un pecador convertido en prosélito, que ahora reniega de los años que pasó sirviendo a Trump.

Cohen, que está descalificado para ejercer la abogacía, será interrogado sobre los reembolsos que recibió de Trump, pagos que forman la base de 34 cargos de falsificación de registros comerciales contra Trump.

El caso en contra de Trump probablemente tenga éxito o fracase en función de si los jurados creen la versión de Trump o se inclinan hacia las afirmaciones de la defensa presentadas en los argumentos de apertura de que Trump es un "admitido "mentiroso" con una "obsesión por obtener al presidente Trump".

Los abogados defensores de Trump han argumentado que Cohen mintió nuevamente cuando testificó en el juicio por fraude civil de Trump el año pasado. Afirman que Cohen ha ganado
